## AGREEMENT

This is a contract between Petside Manor (Kennel) and the Pet (s) owner and /or owner's representative whose signature appears below.

1. The owner (or owner's representative) agrees to pay the rate of boarding in effect or accommodation chosen on the date the Pet (s) is checked into the kennel as indicated on the Pet Information Sheet.
2. The owner (or representative) further agrees to pay all costs and charges for special services, ie, grooming, medications, veterinarian costs incurred for the health and well-being of the Pet (s) during the time the Pet (s) is in the care of the kennel.
3. Boyette Animal Hospital is happy to provide the necessities to improve your pet's boarding stay. These items will include bedding, and food/water dishes. Boyette Animal Hospital will not be held liable for the loss or damage of any personal belongings the owner wishes to leave with their pet.
3. The owner further agrees that the Pet (s) shall not leave the kennel premises until all charges, including veterinarian charges are paid by the owner.
4. The owner specifically represents that he or she is the sole owner of the pet, free and clear of all liens and encounters.
5. If the Pet (s) becomes ill or if the state of the Pet(s) health otherwise requires professional attention, the kennel in its sole discretion may engage the services of a veterinarian or administer medicine or give other attention as deemed by the kennel to be necessary for the health and well-being of the dog (s) and the expenses therefore shall be promptly paid by the owner at the time of check-out.
6. All terms and conditions of this contract shall be binding on the heirs, administrators, personal representatives, and assigns or the owner and the kennel.

All dogs are boarded or otherwise handled or cared for by kennel without liability on kennel's part for loss or damage from disease, death, running away, theft, fire, injury to persons, other dogs or property by said dog, or other unavoidable causes.

Owner represents that said dog (s) have not been exposed to Distemper, Rabies, or kennel cough. Owner hereby represents and acknowledges to Petside Manor that said dog (s) vaccinations are current (within the past 12 months of boarding)

The owner of said dog (s) and his/her heirs, legal representatives and assigns hereby agree to pay all costs, charges, and expenses, including lawyer's fees, investigative fees, court costs, and expenses otherwise incurred because of the failure on the part of said owner to pay the boarding suit is filed

or an appeal taken any unpaid balance shall bear interest at the rate of \_\_\_\_%per annum until paid in full.

The signing of this agreement denotes blanket consent now and for any and all times in the future of our boarding, grooming, special services (ie. Administering medicine, veterinarian charges, (etc. ) are provided.
